1.1 Evaluations

- 2. There is a lot of important information here: timelines, procedural safeguards
- 3. B-G-2, number 3. Assessments "if any" are needed. Uses the word "targeted."

1.1 & 1.2 Evaluations/ Reevaluations

- 1. Like most of the manual, this is really getting into the particulars of the law for given situations surrounding Evaluations and Reevaluations.
- 2. Please seek the guidance of your Coordinator in specific situations.
- 3. B-6 and page B-7, interesting if no further evaluation data needed...

2.1 & 2.2 Eligibility Determination

- 1. There are 27 pages of documents.
- 2. Section 8.05 on page C-19 looks at particulars of Special Education and how it interacts with charter schools.
- 3. Each of the disabilities is covered in these documents.

4.1 & 4.2 Free and Appropriate Public Education (FAPE)

- 1. Perhaps one of the most discussed points in our field. What is FAPE?
- 2. Beginning section 300.17 on page D-1 a definition with general descriptors is laid out. Really a very important section to grasp and use as a guide in your work.

5.1 & 5.2 The I.E.P

- These are federal regulations that make their way into what is commonly known as the IEP.
- 2. In document 5.2, section E-G-1 amendments and computer-based IEP program are poignantly explained.

6.1 & 6.2 Placement/LRE

- On page F-1, section "LRE Requirements" you will find one of the largest topics in our field.
- 2. Page F-G-1, Placement and Significant Change in Placement.

7.1 & 7.2 Transition Services/Transition and Graduation

Key Points

1. In 7.1 G-G-3, the use of the word "will" in goal examples.

1. In 7.2, shows key terms and their definitions.

8.1 Confidentiality

- 1. This section delves into the particulars of situations where there is an identified dispute between members of the IEP Team, generally, between the school and the family.
- 2. Please contact your Coordinator.

9.2 Procedural Safeguards

- These 27 pages comprise the parental rights and safeguards you provide to families in the IEP process.
- 2. Becoming fluent with these procedures helps you and the IEP Team stay in compliance and follow key timelines.

10.1 and 10.2 Parent Rights and Participation

- 1. This section outlines the guidance related to consent for evaluation, placement, and provision of FAPE
- 2. This section describes meaningful parent participation
- Independent education evaluation process is outlined
- 4. Includes Frequently Asked Questions

11.1 and 11.2 Discipline and Attendance

- This section describes requirements when determining a change of placement
- 2. The obligation to receive educational services when a removal from current placement is outlined
- Manifestation Determination and Due Process is discussed. Teams should consult with CSI Special Education Coordinator
- 4. Attendance considerations and Frequently asked Questions are included

12.1 and 12.2 Private Schools and Out of Home Placements

- This section describes Child Find Obligation for LEA
- Service Plan developed for identified students to describe special education and related services provided by LEA
- 3. This section provides practical guidance for private schools and out of home placements initiated by IEP team or other public entity

13.1 and 13.2 Restraint Regulations

- 1. Provides specific definitions
- 2. Describes basis for the use of restraint
- 3. Describes personnel training and documentation, and notification requirements
- 4. Identifies Frequently Asked Questions

14.1 Section 504

- 1. Describes Eligibility process and procedure under 504.
- 2. Describes Placement and FAPE under 504
- 3. Provides Frequently asked Questions related to 504

15.1 and 15.2 School Choice and Charter Schools

- 1. This section describes federal regulations related to rights of students with disabilities
- 2. This section identifies funds under Part B of the Act to Charter Schools
- 3. Reviews the Rules for ECEA for Charter Schools and Transfers under Public School Choice involving significant change of placement
