Program Plan Responsibilities

- **CSI**
 - **Ensure CSI school compliance to federal and state school nursing and health requirements**
 - **Provide resources and support to schools as they develop and maintain School Nursing and Health Program**
- **CSI Schools**
 - **Complete School Nursing and Health Program Plan During “Year 0” planning**
 - **Adapt School Nursing and Health Program as school changes**
 - **Update CSI’s Career Pathways and School Programs Coordinator with changes to School Nursing and Health Program**



Program Plan Requirements

Human Resources

Section 1: School Nurse Qualifications

- A plan to provide adequate, qualified staff to meet the needs of all students
- A plan to ensure adequate training for school nurse

Section 2: School Nurse-to-Student Ratio

- Identify the number of school nursing staff appropriate for student population

Section 3: Delegation of School Nurse Duties

- Identify the need to delegate school-nursing duties to school-based staff
- A plan to evaluate the performance of school-based staff to whom school-nursing duties have been delegated.

Nursing/Health Office Procedures

Section 1: Immunizations

- Description of your school's procedure for collecting and submitting immunization records.

Section 2: Screenings

- Description of your school's procedure for collecting and maintaining health screening records

Section 3: Medication Administration

- Description of your school's procedure for the administration of prescription and over-the-counter medication to students

Section 4: Infectious and Communicable Diseases

- Description of how school will identify a possible link between high rate of absenteeism and infectious or communicable diseases.

Section 5: Student Health Care Plan

- Describe how students with health care needs will be identified

Section 6: Communication to School Community

- Description of how your school will communicate health-related policies, procedures, and other information to the school community?

Student Wellness and School Safety

Section 1: Behavioral and Mental Health

- Description of the role school nurse will play in supporting the behavioral and mental health of students

Section 2: School Safety and Emergency Preparedness

- Identification of who will create student safety-related policies and procedures
- Identification of the role school nurse will play in student safety-related policies and procedures
