

Addressing Academic and Mental Health Needs



Safe Learning

- 100% of CSI schools began school year with:
- Full-Time In-Person instruction
- Layered Prevention Strategies in Place
- Contingent instruction modalities



Community Needs

- 13 CSI schools offering 100% remote option to families
- All CSI schools are prepared to shift to remote learning if necessary
- All CSI schools have plans for continuity of instruction during instances of remote learning



Building Resiliency

- CSI added 1.0 FTE Mental Health Program Specialist
- Mental Health Consultation and training
- Partnering with local agencies




Prioritizing Funds

- CSI Set aside \$100K annually to support contracted mental health services at schools
- Schools are planning to spend over \$3M on social mental health supports, social emotional learning, and learning loss mitigation.





What would you consider the best ways to use ESSER III funding to address these needs?








Best Fund Use






Thoughts on Proposed Budget






Thoughts on Safe Return to School Plan

- Includes requests through March 15th, 2022

ESSER I


- \$1.5m
- Award period ends Sept 30, **2022**
- 96.8% of funding spent down
**all school funding*

ESSER II

- \$6.3M
- Award period ends Sept 30, **2023**
- 37.7% of funding spent down
**less than 1% CSI Admin*


ESSER III

- \$14.2M
- Award period ends Sept 30, **2024**
- 6% of funding spent down
**CSI admin 11.2%*




