

## Unique Accommodation: Guidance Document on Spoken Response WIDA ACCESS Writing Domain

The Writer/Scribe accommodation for the Writing domain on the WIDA ACCESS assessment is available to a very limited number of students who have a neurological<sup>1</sup> or orthopedic impairment, which significantly limits or prevents the students' motor process of *writing*. There must be a direct connection between the student's disability and the ability to access the assessment. Students must have the spoken response accommodation in their IEP or 504 plan for instructional and assessment purposes. Only students who meet specific guidance criteria may use this accommodation on the WIDA ACCESS assessment and receive a valid score.

The Spoken Response accommodation is not intended for students with illegible handwriting or poor writing skills (this includes students whose spelling and/or word choice may be below grade level or who may have a language-based disability), dyslexia, dysgraphia, dyscalculia, students with behavioral issues to avoid writing, social-emotional delays, students who struggle with writing due to limited instruction, or the student's dictation performance over writing/ typing. It is intended for students who have significant difficulties due to a neurological or orthopedic impairment that affects the student's motor process of writing.

Follow the instructions in the Unique Accommodation Request (UAR) form.

- Enter all the information on the UAR form for WIDA ACCESS.
  - o Complete Criterion 1.
  - o Identify the most recent date of the student's IEP or 504 plan. **The plan date must be within one year of the submission date**. UARs with an "Expected implementation" of an IEP or 504 plan will not be reviewed.
    - When submitting documentation, include only the page(s) of the IEP or 504 plan where the Spoken Response accommodation is documented. **Do not submit the full IEP or 504 plan**.
    - Identify the disability that interferes with the student's access to the domain.
  - There should be a direct connection between the student's disability and the need for the requested accommodation.
  - In the "Request" area, indicate the type of Spoken Response being requested for unique accommodation for WIDA ACCESS:
    - If Speech-to-Text is selected, identify the name of the program used.
  - Starting with Criterion 2, select the response that best answers the Criterion for the student. The Criterion indicates either "STOP HERE" or "COMPLETE THE SUPPORTING DATA." If at any time the selected response indicates "STOP HERE", the team should stop the checklist. "STOP HERE" indicates that the student does not meet the requirements to receive a valid score when using the requested accommodation.
  - In Criterion 2, a summary of the impairment's impact on the student's ability to access the Writing domain must be provided.
  - o In Criterion 3, a summary of the fine motor evaluation **must** be provided.
  - All supporting evidence, documentation, and diagnostic assessments submitted must be completed within the current school year.

<sup>&</sup>lt;sup>1</sup> Note: Qualifying neurological impairments impede access to the motor process of writing. Neurodivergent disorders that **do not** impede access to the motor process of writing, such as dyslexia and ADHD, are not eligible for the Writer/Scribe accommodation.



If all criteria are met, upload the UAR form, current-year supporting data, and the page(s) of the IEP or 504 plan where the Spoken Response accommodation is documented to Google Drive. A UAR submitted without complete information, including current documentation and data, will not be reviewed.

- In Criterion 4, submission data **must** be included. The Criterion 4 data attachment includes:
  - o Spoken Response: Human Scribe or Speech-to-Text<sup>2</sup> for the computer-based test
    - The student's keyboarding sample (unsupported) with the time it took to complete the sample.
    - If unable to provide a keyboarding sample, submit an explanation of the student's inability to provide the sample.
    - If using Speech-to-Text, the student must be able to access the program independently (including self-editing) without teacher support.
  - O Spoken Response: Human Scribe for the paper-based test
    - The student's writing sample (unsupported) with the time it took to complete the sample.
    - If unable to provide a writing sample, submit an explanation of the student's inability to provide the sample.
  - Only submissions with valid documentation will be considered for approval.

## The deadline for WIDA ACCESS UAR submissions is November 24, 2025.

If the request is approved by CDE, the student may receive a valid score on the assessment when using this accommodation.

If the accommodation is not approved and the educational team provides the accommodation during the administration of the WIDA ACCESS Writing domain, CDE will instruct the district to indicate that a non-approved accommodation was used on the assessment. This will result in the WIDA ACCESS Writing domain being invalidated and, in addition to not receiving a Writing score, the student will not receive an Overall Composite Score or a Literacy Score.
